

## NIANTIC BAY YACHT CLUB

### **2024 Dinghy Storage Application**

#### **GENERAL**

Members may reserve a dinghy storage space by completing the attached application ***Any boat stored on club property shall be registered by completing this application for the current season and labeled with the member's name.*** Incomplete forms will not be considered accepted. Applications must be submitted before bringing boats to the Club. Members bringing their boat to the Club before submitting an application shall be charged the daily fee for storage until an application has been submitted and accepted.

The seasonal fee will be invoiced to the member. Payment is due within 30 days from the date of invoice. A penalty of 10% will be charged for each 30 days or part thereof in arrears. Any member with an outstanding balance more than 90 days old is subject to forfeiture of their membership at the discretion of the Board of Governors.

***All Sailing Dinghies used for sailing lessons shall be registered. There is no charge for rack stored and half price for ground storage on a trailer/dolly for sailing lesson boats.***

All boats/trailers and/or dollies that are stored on NBYC property must be labeled with the member's name. Names should be near the transom of the boat. Trailers/dollies should have the member's name located on the tongue near the hitch or handle. ***It is recommended that all parts of the boat be labeled (i.e. rudder, boards, spars, sails, accessories)***

Boat, trailer and any other associated equipment must fit within the marked lines of the ground spaces. Spaces are set up so that a 420's, RS Fava's, Optimist, Lasers, or similar size boats on a dolly or trailer will fit in the Water Side (**WS**) spaces; Lightnings on trailers or similar size boat will fit in the Roadside (**RS**) spaces; Ensigns, J-24's, or similar size keel-boats will fit in the overflow lot (next to the pump house) (**PH**) spaces.

Rack Storage is available for Lasers, sailboards, SUP's, kayaks (**LR**), and Opti's (**OR**).

***\*NEW\* ~ ABC ground (ABC) These spaces are for Opti's used for lessons. See detail in regulations.***

In the water (**IW**) spaces for small dinghies, RBI's, inflatables are available on the west side of the dinghy dock. Dinghies, RBI's stored in the water with motors shall leave motors down or have motor protection of a bucket over the prop. ***The boat shall be labeled with the member's name visible from the dock.***

**The NBYC website and current Yearbook contains Waterfront Guidelines and Dinghy Storage Regulations that apply to your application request. Applicants are responsible for reading and following these rules.**

#### **LIABILITY**

**The Niantic Bay Yacht Club assumes no liability for any damage, theft, flooding, or other loss to a member's boat or vessel while in or out of the water at the NBYC facility.**

All boats must be insured with liability coverage of \$300,000 minimum. Boats may be required to be removed from club property during storm conditions. You must list phone numbers and emails addresses so you can be contacted in case of emergency on the application.

Members and their guests are responsible for following all waterfront guidelines and policies found in the current year-book.

#### **OFF SEASON STORAGE**

Members may store their boats in the overflow lot next to the pump house and/or the back parking lot after docks out and before docks in provided there is space available. An application must be made before storing boat. There shall be no sanding, scraping, or painting of boats in the dry sail area.

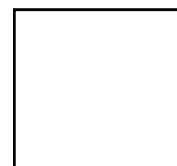
